Our Major in Economic and Political Studies provides students with a strong background in two of the most important areas of study to understand the process of Globalization and the effects on governments, business and citizens.

## Program Overview

---

### Economic & Political Studies

Economic and Political Studies has emerged as the most important area of study for students to understand the various processes of Globalization. This combined Major provides students with the necessary analytical and theoretical tools to understand how changes in the structuring of the global economy effect governments and economies at the national, provincial and local levels.

### Fields of Study

**Canadian Politics & Economy** involves the study of the institutions and processes of Canadian politics and government. The focus is on developing a critical understanding of how politics and government policies are structured in this country and our economic and political relationship with other nations.

**Political and Economic Theory** is the examination and discussion of important ideas. The emphasis is on the critical analysis of the theories of classical political philosophy as well as the ideas of contemporary political and economic thinkers.

**Comparative Studies** is a multidimensional field incorporating studies of institutions and processes, public policy theories of the state and economic development. This field deals with studies of Developing Nations and Developed nations, with studies of a single foreign country e.g. United States of America, Mexico.

**International Studies** is one of the oldest fields of economic and political study. It involves the study of relations between states, diplomacy, war, peace and, of course, international organizations and international political economy.

**Public Policy and Administration** is probably the newest part of the discipline. The emphasis is on explaining the outputs of government--what governments do (and do not do). As well there is an

attempt to assess policy making structures with an eye towards prescription as well as analysis.

### Economic & Political Studies at TRU

Courses are offered in Economics and Political Studies at all levels of undergraduate education. The offerings in first and second year are quite broad providing interested students with a wide ranging introduction to both Economics and Political Science. In addition, we continue to develop new courses at the upper-level in areas of community development, the environment and sustainability, and area studies.

## Academic Requirements

### Major in Economics and Political Studies

The Major in Economics and Political Studies is a unique cross-disciplinary degree offering which provides students with the political and economic skills and knowledge for a broad range of government and private sector jobs.

The Major in Economics and Political Studies program requires the completion of at least 57 credits in Economics and Political Science, of which a minimum of 30 credits must be at the upper-level (300 and 400 level) and of which no less than 6 credits must be at the 400 level. The program consists of core and elective courses.
