4.b. James Gordon and Aaron Wiebe on the 'nuggets' they learned about at AASHE conference in October. James spoke briefly on four:

- a. *Lime* – e-scooters, e-bikes and regular bikes
- b. Certification for the International Society of Sustainability Professionals (ISSP)
- c. Closing Keynote - Dr. Paul Shrivastava, Chief Sustainability Officer at Penn State University: October as Sustainability Month; More Living Labs; Sustainability is an appeal to Head, Heart and Hands.
- d. Study about 'Sustainability in the C-Suite' (in the highest administration levels of an institution)

- f. Green Labs--Green Chemistry.

- The 2019 AASHE conference will be in Spokane, Wa; TRU asked to be a co-host; call out for early-bird registrations; all ESAC members are asked to consider presenting at the conference. Jim would love to see a 'bus-load' of TRU representatives.
- UN conference in Chile early November.
- Transportation: ZipCar numbers increased from 20 to 200 members since 2016; looking into expanding ZipCar network
- Biomass presentation at February 6 meeting and all ESAC members should come prepared to make a decision on the future of using biomass at TRU. Members from UNBC will present,
