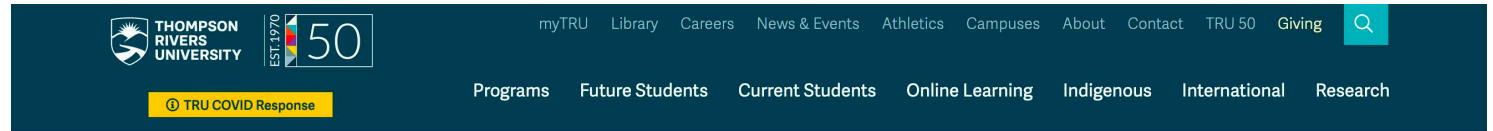

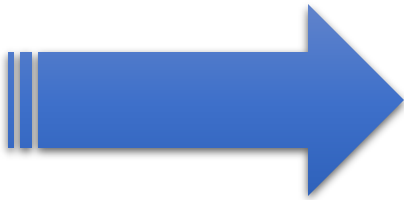
C. A Bursary, Award, or Prize requires a minimum Undergraduate GPA of 2.00 in your most recent full-time semester and enrolment in at least nine Undergraduate credits (unless specific criteria state otherwise). Scholarships require a minimum Undergraduate GPA of 3.50 in your most recent full-time semester and enrolment in at least 12 Undergraduate credits in both the qualifying and receiving semesters.

D. A Bursary also requires demonstrated financial need using TRU's standardized assessment (modelled on government need assessment criteria), and is only for Canadian citizens or Permanent Residents.

E. Students may only apply once during the academic year. If exceptional circumstances arise which would warrant a second application, students may set up an appointment with a Student Awards Advisor. If your prior semester application has a status of "Eligible, No Offer", your application will automatically be carried forward and considered for funding again within the same academic year.
